## 1. CONSTITUTION

The Committee shall consist of ex-officio Governors – the Chair and Vice Chair of the Governing Body and the Headteacher – and at least three other Governors. The Committee shall meet at such frequency as is required to meet the needs of the School in respect of the Committee's responsibilities, and not less than once per term. The Committee must elect a Chair (and Vice Chair at its discretion) annually at its first meeting each academic year.
